



Clean Break Virgin Money London Marathon

TERMS AND CONDITIONS

To participate in a run or challenge you must agree the terms and conditions below. These terms constitute the fundraising agreement between CLEAN BREAK and you, as a participant.

Taking Part

1. I understand that the event is not organised by CLEAN BREAK, but by a third party ("Event Organiser"). It is my responsibility to read any terms and conditions issued by the Event Organisers and to comply with these.
2. I confirm that I am medically fit and that I participate in the event at my own risk. CLEAN BREAK will not be held responsible for injury or illness resulting from my participation.
3. All CLEAN BREAK participants must be aged 18 or over by the Event Date.
4. I acknowledge that Charity Places are non-transferable.
5. I understand that, if applying for a Charity Place, CLEAN BREAK may need to notify the Event Organiser that I will be taking part and share limited personal information so that the Event Organiser can contact me to confirm my registration for the event. I understand that, if needed, it will be my responsibility to complete the Event Organiser's registration also.
6. I will contact CLEAN BREAK if I am unable to take part in the event and forward any money raised to CLEAN BREAK for their work which supports women with lived experience of the criminal justice system.
7. The deposit is non-refundable if the participant is unable to take part in the event. If CLEAN BREAK decides to rescind the Charity Place, then the deposit will be returned to the participant. If the Event Organiser cancels the event, the deposit will be returned to the participant.

Fundraising

1. I will use my best endeavours to raise money for CLEAN BREAK in connection with my participation in the event and, aim to raise at least the specified sponsorship target if I have accepted a Charity Place. I understand that Gift Aid doesn't count towards my sponsorship target.
2. I acknowledge that the deposit does not contribute towards my target and will only be returned to me if I am successful in achieving the sponsorship target as specified by CLEAN BREAK.
3. I understand and will make clear to those who support my fundraising that any money I send into the CLEAN BREAK will be treated as a donation. Donations are generally non-refundable, even if I fail to take part in or withdraw from the event.

4. Any fundraising I undertake in connection with my participation in the event will be for CLEAN BREAK only (applicable to Charity Place participants) and I will forward all monies donated to the Charity either by cash, cheque, CAF or via an online giving provider no later than four weeks after the event.

Photos

1. I understand that there may be photography at the event, and I grant permission for CLEAN BREAK to use photographs, motion pictures, quotes, or any other record of my participation in my chosen event for the purpose of marketing future events online and on print materials, for a period of 5 years.

2. I understand if I do not wish my photograph to be taken and/or used, I should inform CLEAN BREAK so that they can make the necessary arrangements. I understand that if I wish to withdraw my consent at any time, I should email development@cleanbreak.org.uk. I also acknowledge that while CLEAN BREAK will use all reasonable endeavours to comply with any such notice of withdrawal of permission it cannot guarantee that materials in public circulation at the date on which the request is received will be withdrawn immediately.

Confirmation

I confirm I have read, understood and agree to all the terms and conditions set out above, and understand CLEAN BREAK may terminate our relationship if I am in breach of any of the terms and conditions.
